

## POTTER'S WEEKEND IN DUNEDIN

Dunedin's Hopes Bowls Stadium plays its 'Potter's Weekend' this weekend with Professional Bowls Association qualifiers for the World Indoor Singles and World Indoor Pairs. The early feature matches between top 50 players include Andrew McCallum against Nigel Thompson, and Ken Walker versus Adam McGregor both on Saturday afternoon in the singles. McCallum played at the Potter's Leisure Resort in Norfolk in 2006 but Thompson has beaten him twice in PBA singles, and McGregor knocked over PBA Life Member Walker in this event last year.

The two events will likely get down to the semifinals to be completed on 20 August.
