WELLINGTON FINALS DAY TAKING SHAPE

'Potter's Weekend' at the Naenae club in Wellington resulted in four semifinalists in the World Indoor Singles qualifier, and two finalist pairs in the World Indoor Pairs qualifier, making it through to Wellington's local finals day on August 12.

Wellington will face Wairarapa in both the singles semifinals with Sonny White to play Gavin Hamlyn, and Mark Finlay up against Garry Muriwai. Hamlyn is defending his NZ Finals Weekend spot from last year winning the 2022 Wellington World Indoor Singles qualifier but will need to be wary of White who tipped over Bay of Plenty's Dave Jones, and Bowls Wellington General Manager Blake Signal on his way to the semifinals. Muriwai is the most experienced of the quartet having played in the 2003 World Indoor Singles at Potter's Leisure Resort in Norfolk, England but will also need caution against Finlay who upset another former traveller to the UK in Ray Boffa.

Signal had better fortune in the World Indoor Pairs qualifier playing with daughter Lily. They had to fight back from a set down twice during the day. They will be up against NZ PBA Chairman Richard Corry and his top 50 ranked clubmate Ian McLeod who also overcame a one set deficit in their semifinal before swapping lead and skip positions to turn the match around.

The next venue to play their 'Potter's Weekend' will be the Hopes Stadium in Dunedin on July 21-23.
